## **ASI Cookbook Recipe of the** Month!

Hot Cocoa Poke Cake

Ingredients:

-1 15.25-ounce box of chocolate cake mix (plus ingredients listed on the box).

-1 7-ounce jar of marshmallow creme.

-2 TBSP water.

- -1 11.25 ounce of chocolate fudge sauce.
- -1 8-ounce tub of whipped topping thawed.
- -2 packets of hot chocolate mix (1/4 cup).
- -1 1/2 cups mini marshmallows.
- -2 TBSP mini chocolate chips

Directions:

- 1. Prepare the cake mix per box instructions. Utilize a 9x 13 pan. Allow cake to cook to room temperature.
- 2. Use the handle of a wooden spoon to poke rows of holes into the cake, about 1 inch apart.
- 3. Add the marshmallow creme and water to a microwave-safe bowl and microwave for 20 seconds. Mix until well incorporated. The marshmallow creme should be a pourable consistency. If it is too thick to pour, microwave for an additional 10 seconds and stir well.
- 4. Pour the marshmallow creme over the cake. Use a rubber spatula or the back of a spoon to spread the marshmallow and press it down into the holes.
- 5. Heat the chocolate fudge sauce according to the directions on the jar. Spread the chocolate sauce over the top of the cake. Allow fudge sauce to cool.
- 6. Add the whipped topping and hot chocolate mix to a medium bowl and gently fold until well combined.
- 7. Spread the chocolate whipped topping over the cake and refridgerate for ateleast an hour to allow the flavors to meld.
- 8. When ready to serve, sprinkle the mini marshmallows and chocolate chips over the cake, slice and enjoy.
